

The School also ensures to follow FN-21 'Accounting by schools' as issued by the Institute of Chartered Accountants of India (ICAI) for proper accounting treatment.
5. That the school shall observe the relevant provisions of RTE Act, 2009, DSEAR, 1973 and directions/instructions issued by the Department from time to time.
6. That the school shall comply with the orders/instructions of DoE and judicial pronouncement w.r.t. utilization/maintenance of school funds.
7. That the school shall comply with the orders dated 07.11.2017/guidelines of DoE and judicial pronouncements w.r.t. safety of the students and shall take all necessary steps to this effect.
8. The school shall make sure that the aforesaid terms and conditions are complied with by them in letter & spirit.


